LKP Co., Ltd. owns a TPU mat production plant, which directly manufactures, produces and sells.







Scientific 3-level structure






STRUCTURE

- Rug-style DIY mat consisting of 12 pieces.
- Consist of 2 pieces for center, 6 pieces for side, and 4 pieces for corner
- Simple but robust 7-level locking fastening structure



- The thickness of 2cm is the same, but the size of each product (center type/side type/corner type) is different.
- The colors(pink, blue, green) of the center type/side type/corner type fastening parts are displayed separately for better understanding of each product, and the colors of the actual products are the same.
