




### **How does DERMAMAGIC work?**



Silicone's primary mechanisms of action, when used as a topical agent for scar management, are its abilities to induce hydration and promote a homeostasis of oxygen and moisture on the surface of the skin. This homeostasis, or optimal environment, allows dry skin and scar tissue to regain elasticity, hydration, and tensile strength after damage or injury.



Silicone also helps to regulate collagen production at the scar site. When a person sustains a wound, epidermal keratinocyte and fibroblast cells synthesize massive amounts of collagen, a common structural protein, to rebuild the damaged skin.

But if left unchecked, collagen buildup can lead to irregular scarring in the form of keloids and hypertrophic scar formations. By applying silicone ointment to the scar bed,

fibroblast activity is scaled back and collagen production is normalized. This has the effect of flattening and smoothing scars, helping them blend in with the surrounding tissue.

### **Usage and Precautions**



For surgical incision, use the dry incontinence wounds after removal of seams. ("Never use" it for open wounds, unhealed wounds, or infected wounds)

Scars occurring within the last 1 year have an improvement effect.

Apply thinly and reapply at the point where the foundation effect decreases.

Although there is a difference depending on the type of scar, age and constitution of the scar, the total duration of treatment for scars less than one year is about two to four months.

(At least 6 months of Keloids)

#### **User** manual



- 1. Begin using DERMAMAGIC when wound has healed or sutures have been removed. Do not use on any open wound.
- 2. Clean and dry the scar completely.
- 3. Apply only a thin layer of DERMAMAGIC once or twice daily.
- 4. DERMAMAGIC self-dries within 5 minutes. If drying time takes longer, it means that you have applied too much. Over-application does not increase its efficacy, so do not overuse.
- 5. Apply for 3-6 months. After shower or working-out, please apply it again.
- Storage: 1. Room temperature (1~30°C)
  - 2. Keep out of reach of children
  - 3. Close the lid tightly after use









